- Insect Control Carmelo Mastrangelo, President of Nick Felicione Pest Control was at the meeting to discuss their pest control business. They handle lawn and ornamental fertilization and weed control. Recommend 6 applications pest control and weed control for 12 months. They do not do driveways. All granular application for fertilization but may have to spray depending on the time of the year. Four applications of fertilization within the year.
- Pool Water Quality (Blue Pools) not discussed
- Clubhouse Janitorial (Office Pride) not discussed
- Cable TV (Comcast) not discussed

New Business

- Yard Debris Disposal Day for Pick up Wednesday and Saturday is the debris pick up day but homeowners will put stuff out after the debris truck has left. Board approved landscape debris can put out to the swale the day before.
- Website should go live soon, but will need to be hosted.

Homeowner's Forum:
